



# Canyon Crest Academy Foundation - Fall League

## WAIVER, RELEASE, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT FOR RISKS, INCLUDING BUT NOT LIMITED TO, COMMUNICABLE DISEASES (COVID-19)

In consideration of Participant being allowed to participate in Canyon Crest Academy Foundation camp, clinic or tournament programs, sanctioned activities and events (collectively "Sanctioned Activities"), the undersigned understands, acknowledges, and agrees that by electronically signing this Waiver, Release, Assumption of Risk and Indemnification Agreement:

1. Participant's participation in such Sanctioned Activities inherently includes risks of (1) possible exposure to and illness from infectious diseases and viruses including but not limited to MRSA, influenza, and COVID-19 including Participant contracting an infectious illness, disease or virus through airborne transmission and physical contact with objects or surfaces which may be infected with such illness, disease or virus; (2) forceful contact with the ground, other participants, sports equipment, or other objects; (3) slips, trips and falls; (4) defective equipment; and (5) risks of the sport involved in the Sanctioned Activities. All such risks may cause serious and permanent disability, illness, injury and/or death.

2. PARTICIPANT KNOWINGLY AND FREELY ASSUMES ALL SUCH INHERENT RISKS, both known and unknown, EVEN IF ARISING FROM THE ACTIVE OR PASSIVE NEGLIGENCE OF THE RELEASEES (as defined below) or others, and assumes full responsibility for and all inherent risks arising from or related to participation in the Sanctioned Activities; and,

3. Participant agrees to comply with the stated and customary terms and conditions for participation in such Sanctioned Activities as regards to protection against infectious diseases or viruses including all rules and policies which may be promulgated from time to time by Releasees (as defined below). If, however, Participant observes any unusual or significant hazard during Participant's presence or participation in the Sanctioned Activities, Participant will remove themselves from participation and bring such to the attention of the nearest official immediately; and,

4. Participant and any parent or legal guardian signing below, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, ACQUIT, AND HOLD HARMLESS Canyon Crest Academy, Canyon Crest Academy Foundation and San Dieguito Union High School District, and its or their officers, directors, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, coaches, teachers, officials, and Sanctioned Activities leaders and organizers, and if applicable, owners and lessors of premises used to conduct the Sanctioned Activities (all collectively referred to herein as "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE ACTIVE OR PASSIVE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. Participant, for themselves and on behalf of their heirs, assigns, personal representatives and next of kin, hereby agree to defend and indemnify RELEASEES for all such claims, causes of actions, allegations or matters arising out of, relating to, based upon or in any way connected to Participant's participation in such Sanctioned Activities.
